## **GUIDELINES FOR CONTRIBUTORS**

effective from volume 48 (2018)

Contributions submitted to *Ancient Society* are subjected to double blind peer review. All text must therefore be carefully anonymized before submission to the journal.

Papers (in English, German, French, Italian, Dutch) are to be submitted to the editorial secretary, preferably electronically (on data carrier or as e-mail attachment), in a standard word-processing application or in PDF format; a hard copy printed on A4 paper, on one side only, may be sent by post.

All contributions must be accompanied by an abstract in English of 15 lines at most. Articles should not exceed 25 to 30 pages in length (incl. footnotes).

Submissions are evaluated by qualified reviewers, members of the editorial and consulting board and/or external scholars from Europe or elsewhere.

Accepted submissions will in principle be published in the next issue in which space is available.

## Text:

Text must be provided in a form suitable for digital editing and typesetting. A standard Unicode font (e.g. Times New Roman) should be used and formatting restricted to a minimum. Notes are to be presented as endnotes. Latin is italicized. Greek text should be quoted in a Unicode Greek font, but isolated words may in some cases be transliterated and italicized.

Tables, graphics and artwork may be incorporated in the submitted text file, but must also be provided in a separate file.

## **Quotations:**

Passages quoted are set between double quotation marks (""); longer passages (more than 3 lines) are inset as separate paragraphs in smaller type and without quotation marks.

Latin: in italic without quotation marks; longer passages are inset and not italicized. Greek: no quotation marks necessary.

Footnotes are to be numbered successively from '1'. A note attached to the title, e.g. for acknowledgements, is marked with an asterisk (\*).

- in general: do not use f./ff., give exact page references.

All works cited must be listed in a bibliography at the end of the article; this bibliography must be confined to the works referred to in the notes; entries are listed as follows:

 the author's first name is spelled out in full; titles of monographs and collective works are italicized; titles of series (in roman) should be specified; names of publishers are omitted:
